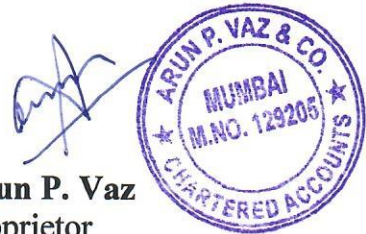
Our responsibility is to express an opinion on these financial statements based on our audit.


